UNCLAIMED SHARES:

Pursuant to the requirements of Regulation 39 of the SEBI (LODR) Regulations, 2015, the Company have, on 26th March 2021, transferred 242200 Equity shares of Rs.2/- each belonging to 68 Folios of shareholders to a new folio created in the name of the Company termed as RASI ELECTRODES LIMITED UNCLAIMED SHARES ACCOUNT for subsequent dematerialisation of the subject shares to be held in Demat Suspense Account in custody on behalf of these 68 shareholders till such time they claim the same. These shares pertain to allotment of shares pursuant to split of 1 Equity shares of Rs.10 each into 5 Equity shares of Rs.2 each on 11th April 2015, which have been returned undelivered and lying unclaimed with the RTA. These shares have been dematerialized and lying in credit in a separate demat account No. 1201090020392399 as on 31ST MARCH 2023 and are being held on behalf of the shareholders till they claim the same after fulfilling the required procedure. The voting rights on these unclaimed shares are frozen till such time the rightful owner claims these shares. During the half year ended 31.12.2023, the Company and its RTA, have processed NIL claim for repossession of NIL shares by its owners.
