These shares pertain to allotment of shares pursuant to split of 1 Equity shares of Rs.10 each into 5 Equity shares of Rs.2 each on 11th April 2015, which have been returned undelivered and lying unclaimed with the RTA. These shares have been dematerialized and lying in credit in a separate demat account No. 1201090020392399 and the balance as on as on 31ST DECEMBER 2025 2025 is 8700 equity shares which are being held on behalf of the shareholders till they claim the same after fulfilling the required procedure. The voting rights on these unclaimed shares are frozen till such time the rightful owner claims these shares.
