- The above un-audited results for the quarter ended 31st December 2014 was reviewed by the Audit Committee and approved by the Board of Directors at their meeting held on 11th February 2015.
- The Board of Directors have allotted 240000 Equity shares of Rs 10 each at a premium of Rs 35.82 per share to Promoters on conversion of Warrants on 28.08.2014. The proceeds amounting to Rs 85.97 lakhs have been utilised for working capital purposes.
- The Board of Directors have allotted 951100 Equity shares of Rs 10 each at an issue price of Rs 54 per share to Public subscribers on a private placement basis on 29.09.2014. The proceeds amounting to Rs 513.59 lakhs is being utilised for the ongoing expansion of plant capacity and working capital purposes.
- The Board of Directors have allotted 1000000 Convertible Equity Warrants to Public and Promoters convertible into equal quantity of equity shares within a period of 18 months at an issue price of Rs 54 per share on a private placement basis on 29.09.2014. The proceeds amounting to Rs 135.00 lakhs, being the subscription money received, is being utilised for the ongoing expansion of plant capacity and working capital purposes.
- The Company operates in the single segment and as such segmental reporting is considered not applicable.
